1:3 or 1:25 with water.

High pressure equipment; dilution ratio

1:70 with water.

Spray soiled surface and wait for a few minutes before rinsing with water.

Successfully removes resinous residues from both Stainless Steel and Aluminium Moulds without affecting metal surface despite the high pH.
